For the answer will be used in preference to the same channel adopted by the person concerned for sending the model

The request, if legitimate and justified, can be exercised free of charge; if an amount is chargeable as a reimbursement of expenses, the person concerned will be notified in advance and confirmation will be requested before proceeding.

The maximum times for the emission of the response by Stella SpA are fixed in 30 days from receipt of the completed form.

If the form is not presented in person to our employees, who will then be able to make a direct identification, you must attach a copy of the identification document indicated on the first page of the form; the photocopy will be taken in the file and kept after affixing a cancellation notice (example: "this document was acquired by Stella SpA together with the form for the exercise of the rights of the data subject submitted on").
