Processing personal data

This page describes the methods of managing the site in terms of processing the personal data of users who interact with the web services found on this Stella SPA site.

The advisory note is provided solely for this site and not for any other website that may be reached by the user by following a link.

Pursuant to article 13 of Regulation EU 2016/679 (GDPR), the company, as the Controller, informs you that personal data acquired will be processed in full respect of the rights to fundamental freedoms, as well as the dignity, of the interested party, with particular reference to confidentiality and personal identity and the right to the protection of personal data.

Pursuant to article 13 of the aforementioned Regulation, therefore, we provide you with the following information:

Navigation data

The information systems and software procedures used to operate this website acquire, through their normal operation, certain personal data the transmission of which is inherent to the use of communication protocols used on the internet.

This involves information which is not collected to be associated with an identified interested party but which, by its very nature, could, through processing and association with data held by third parties, allow a user to be identified.

This category of data includes the IP addresses or computer domain names used by the user who accesses the site, addresses in the URI (Uniform Resource Identifier) notation for the requested

resources, the time of the request, the method used to submit the request to the server, the size of the file obtained from the service in response, the numerical code indicating the status of the response given by the server (OK, error, etc.) and other parameters relative to the user's operating system and computer environment.

This data is used for the sole purposes of obtaining anonymous statistical information on the use of the site and checking the site's correct operation and is deleted immediately after being processed. The data could be used to ascertain responsibility in the event of a hypothetical computer crime damaging the site.

Data supplied voluntarily by the user

The optional, explicit and voluntary sending of an email to one or more of the addresses indicated on this site leads to the subsequent acquisition of the sender's address, which is needed to respond to any request, as well as any other personal data that might be included in the message.

Specific summary information will be progressively reported or displayed on the pages of the site set up for particular on-request services.

Personal data will be processed exclusively for the purposes connected with and/or instrumental to browsing the site excluding, therefore, any other use and/or any use conflicting with those of the "interested party".

Processing information that concerns you will be based on the principles of correctness, lawfulness, transparency and safeguarding confidentiality, and processing and storage will be done with electronic instruments and by paper means for the time strictly necessary to fulfil the purposes for which the information was collected.

Specific security measures are followed to prevent any loss of data, illicit and improper use of data and unauthorised access to the data.

Conferring data is optional. However, refusing to provide personal data pertinent to the collection purpose may render it impossible for you to obtain that which you might request.

Processing connected to this site's web services is done at the offices of Stella SPA and is carried out by our data processing personnel and by our hosting providers.

Your personal data will not be subject, in any case, to disclosure without your specific consent.

Use of cookies

The Stella SPA internet site does not make use of cookies to send information of a personal nature, nor are so-called persistent cookies of any type used, nor user tracking systems.

The use of so-called session cookies (which are not stored in a persistent way on the user's computer and are deleted when the browser is closed) is strictly limited to sending session identifiers needed to allow for secure and efficient browsing of the site.

So-called session cookies used on this site avoid the need for other computer techniques that could potentially jeopardise the confidentiality of the user's browsing behaviour, and do not allow the user's personal identifying data to be acquired.

Any external links contained on our pages take users to third-party sites that may use cookies of various kinds. We, therefore, invite you to review the relative advisory notes found on those sites and to give (or deny) your consent.

Managing individual cookies is entrusted to the user who, manually or through automatic settings on his/her browser, may decide which cookies to accept, with the option of deleting, at any time, some or all of the cookies present in his/her browser.

At any time, you have the right to lodge a complaint with the relative supervisory authority.

If processing is based in whole or in part on you providing your consent, you have the right to freely revoke this consent, at any time, by contacting any of the addresses given above. Processing carried out pending consent, and the relative legal effects, will, however, remain valid even after any such consent is revoked.
